

**SUMMARY ANNUAL REPORT
FOR TOYS“R”US EMPLOYEE BENEFIT PLAN**

This is a summary of the annual report of the Toys“R”Us Employee Benefit Plan, EIN 22-3260693, Plan Number 501, a welfare plan, for the period July 1, 2015 through June 30, 2016. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Toys“R”Us has committed itself to pay all uninsured claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with Aetna Life Insurance Company, Kaiser Foundation Health Plans, Inc., Kaiser Foundation Health Plan of Hawaii, and Triple-S Salud, Inc. to pay insured health, major medical, dental, HMO, organ & tissue transplant, and prescription drug claims incurred under the terms of the plan. The total premiums paid for the plan year ending June 30, 2016 were \$4,692,923.

Because the contracts with Aetna Life Insurance Company and Triple-S Salud, Inc. are so called “experience-rated” contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending June 30, 2016 the premiums paid under such “experience-rated” contracts were \$371,800 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$103,430. Kaiser Foundation Health Plan, Inc and Kaiser Foundation Health Plan of Hawaii are so called “partial experience-rated” contracts. Of the total insurance premiums paid for the plan year ending June 30, 2016, the premiums paid under such “partial experience-rated” contracts were \$3,520,098.
